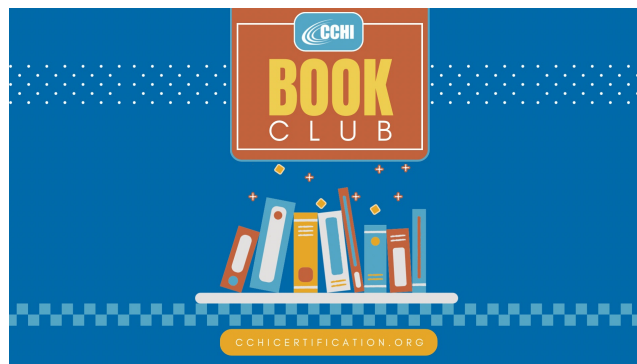

### Top Headlines

"Earlier this year, President Trump issued Executive Order 14224 declaring English the "national language" of the U.S. and directing the Department of Justice (DOJ) to dismantle decades of federal language access work, though the order cannot override civil rights laws. In April, DOJ rescinded its 2002 LEP guidance, and on July 14 Attorney General Pamela Bondi issued interim guidance encouraging federal agencies to scale back multilingual services, suspend LEP.gov, replace human interpreters with AI, and operate some programs exclusively in English. While the Bondi Memo misrepresents legal precedent, existing laws—including Title VI of the Civil Rights Act and statutes like the Affordable Care Act and Voting Rights Act—still require recipients of federal funding to provide meaningful access for people with limited English proficiency, with violations risking liability. The memo affects only federal agency services directly, and DOJ plans to issue new guidance by January 2026, but advocates urge state and local governments to maintain robust language access despite federal cutbacks. After months without meaningful communication access, a deaf asylum seeker has finally been released. A federal judge affirmed what should be a given: that full participation in legal proceedings is a right, not a privilege.
